The NISOA Executive Board and the NISOA Annual Convention Delegates approved the following action items on July 23, 2004 in Orlando, Florida.

**1.0 Policy Code 900.11/. 28: High School Membership Fees:**

Beginning January 1, 2005 the fee structure shall be:  
College Member \$10  
New Member \$20  
Renewal HS Member \$15

**2.0 Policy Code No. 500.1751: NISOA NRP Assessment Fee:**

Effective 2005, the NISOA National Referee Program Assessor fee shall be not more than \$80 or ½ the game fee; the lesser of the two.

**3.0 Policy Code 200. 5 National Referee Program:**

Add: For reinstatement to the NRP, the individual shall use a standard form to be submitted to the respective Regional Area Coordinator, who shall determine the status, then send it to the National Director with a recommendation.

The following reasons are acceptable:

Military Duty; Personal Injury/Illness; Family/Personal Concerns and Educational Issues.

The reason must be placed on the form when applying. Individual reinstatement shall have had membership within the recent class to be reinstated at the last level. Seeking reinstatement of prior membership may be considered with the possibility of grade reduction. The individual shall meet all standards of the level for consideration into the next clinic.

Change: An applicant is required to acquire 2 assessments from two" certified" NISOA Assessors.

Change: Fee for certification shall be \$140.

Change: Apply a late fee of \$20 to the application fee after the deadline date of March 1; and additional \$20 late fee to the NRP Clinic fee to be applied after the deadline date of April 1.

**4.0 Policy Code No. 500. 1741: Regional Area Coordinator**

Delete responsibility #5 and add: the RAC is available for consultation, but need not provide written reports on all NRP members.

Add responsibility to #10: NIRSA to be contacted by RAC.

**5.0 Policy Code No. 900. 11: NISOA Assessor Registration Fee**

Effective with 2005 registration, the NISOA Assessor Fees shall be:

National Assessor \$60  
Regional Assessor \$50  
Local assessor \$40
